### Description of Change:

Cypress announces the qualification of UTAC Thailand Limited (UTL) as an additional assembly site for select 28-Lead SOIC, 18.11x7.62x2.36 mm, Pb-Free products. These products are RoHS and REACH compliant.

**Approximate Implementation Date:**

Effective 90 days from the date of this notification or upon customer approval, whichever comes first, all shipments of the part numbers in the attached file will be assembled at UTL or other approved assembly sites.

**Anticipated Impact:**

Products assembled at the new site are completely compatible with existing products from form, fit, functional, parametric and quality performance perspectives.

Cypress also recommends that customers take this opportunity to review these changes against current application notes, system design considerations and customer environment conditions to assess impact (if any) to their application.

**Method of Identification:**

Cypress maintains traceability of product to wafer level, including wafer fabrication location, through the lot number marked on the package.
